MBI Chair Report – February 2017

Tradition 2: *For our group purpose there is but one ultimate authority—a loving God as He may express Himself in our group conscience. Our leaders are but trusted servants; they do not govern.*

I have been in OA long enough to see this tradition work. More than once, I have witnessed disagreement about an issue. Once it was about the length of the meeting. Another time, it was about something presented in a meeting that some felt was not appropriate. Both times, there were some hard feelings. The group voted on the length of the meeting. I think that it was brought up at more than one business meeting before the group voted to make the change. The long term result has been that the group has grown.

When the issue was something done in the meeting that was not seen as appropriate by all, it was discussed at a business meeting. The long term result that I have seen is that relationships have grown. Respect for each other has grown. We have learned from each other.

Reading the chapter on Tradition 2 in The 12 Steps and 12 Traditions of Overeaters Anonymous, one of the ideas that I have found comforting is on page 122. "Not all of our group decisions will be wise and practical. We do make mistakes sometimes and have to look for better answers to a problem. Another group conscience vote can be taken when something needs to be corrected. Like individuals, OA groups learn from their

mistakes—and so does OA as a whole. We find that our Higher Power often leads us through our blunders."

The overriding truth here is that our Higher Power leads us. We start and end our meetings with the Serenity Prayer or another prayer chosen by group conscience. "Our leaders are but trusted servants; they do not govern." Our leaders are chosen by group conscience. They are not in a position of power. They have volunteered to serve in their positions. All of this happens under the loving guidance of our Higher Power.

A great way to recognize our common purpose is with a heartfelt celebration of **Unity Day**, when OA members pause to reaffirm the strength inherent in OA's Unity. December year end: We had very few donations, though they did increase in January 2017. All were from group donations; a list is at the end of this report. Thank you to all of the groups who donated in 2016.

Our expenses for the month were higher than usual due to several one-time items. The website switch to WordPress cost 521.95, within the estimate provided. We paid \$1000 for a deposit for our next retreat, Oct. 6-8 2017 at the Espousal Center in Waltham (mark your calendars!). We will have a flyer available soon. Our annual liability insurance cost \$690, lower than last year but providing the same coverage from a different company through a program for social service agencies, which we are in a sense as a non-profit organization. We paid Pat, our wonderful office worker, \$315.00 including a holiday bonus. Office rent was 405 as usual. We did not meet at Lawrence Memorial for our regular MBI meeting due to bad weather (had a phone meeting instead) so we did not make a hospital donation in December. We paid \$75 to our webmaster and 151.38 to Verizon for monthly phone and internet service.

Looking ahead to January 2017, when this report is being written, our income is up (over 2000 in donations so far) and our expenses are reasonable. January bills include our office insurance for \$747, additional charges for the website, and we will make our quarterly donations to Region 6 and World Service. We are in good financial shape for 2017. Thank you for enabling me to serve as your treasurer for another 2-year term.
