MBI Chair's Report- December 2012

The December meeting was a very busy and productive meeting. There were a variety of motions presented and voted on, they are as follows:

- 1.) A motion was presented by Ron from Medford, the Chair of the Public Information Committee to have 6 posters on buses on Various MBTA Bus Lines for the months of January and February 2013 @ the cost of \$4,150 the motion was passed.
- 2.) A motion was presented by our Webmaster Brandon from Woburn to allocate \$400 as a fund to be used for "back end maintenance" of our new MBI Website that should be up and running by the end of December, 2012 this motion passed.
- 3.) A motion was presented by the MBI Treasurer Kelly from Arlington to provide Pat our Mass Bay Intergroup office employee a onetime Holiday Bonus of \$125 because whenever Pat was called upon to do those extra things that keep the office running even if having to sacrifice some of her own time, Pat has been willing to do so, this motion also passed.

We also discussed whether or not Mass Bay Intergroup would be willing to host the Region 6 Convention for 2014, Ron from Medford reported the Metro West

Intergroup was willing to help Mass Bay Intergroup with the convention and Jean from Somerville said she is willing to be the liaison with Region 6 and the other intergroups so that MBI can host the convention, it was moved and voted on to table the discussion until the January 2013 Mass Bay Intergroup meeting so it can be determined whether or not other local Intergroups such as South Central Mass Intergroup, North Shore Intergroup and possibly Cape Cod Intergroup would also like to help out with the convention.

A motion was also passed to except the following dates for Mass Bay Intergroup Meetings in 2013:

January 13th, February 10th, March 17th, April 14th, May 19th, June 23rd, July 21st, August 18th, September 15th, October 20th, November 17th and December 15th.

Designated Translation Fund Will Be Discontinued.

Delegates at the 2012 World Service Business Conference voted to discontinue the designated Translation Fund as of December 31, 2012. The fund has fulfilled its original purpose to raise awareness of the need to translate OA literature. Translations have become a regular part of doing business as OA continues to support translations through the annual budget of the International Publications/Translations Committee. Although fund contributions will not be accepted after December 31, all money remaining in the fund will be used to fulfill the fund's designated purpose of translating OA literature. Please continue to support OA, Inc., by donating to the General Fund, the Delegate Support Fund, and the Professional Exhibits Fund.

OA World Service is conducting a survey of all members of the Fellowship.

The purpose of this survey is to determine what is working, and where we can improve OA and strengthen our Fellowship and our efforts to carry the message.
