Income was primarily group donations (see list below), with sales of newcomer packets in January \$30 and \$48 in February.

Expenses: In addition to regular expenses like rent, phone, and office work we also had some higher expenses that occur once a year. In January we had \$703 for insurance for the office (standard business policy), \$144.63 for printing new copies of the bylaws, \$4150 for outreach advertising on MBTA buses (I saw some buses with the ads on them, they looked good), and \$396 for WSBC registrations. In February there was \$348.59 for airline ticket to WSBC, more will follow in the coming months.

I am moving to Peabody in early April and my internet and home phone will be disconnected on March 30th. I should be up and running on April 5th. My cell phone will be working (617-767-9134), but please be patient! I paid the office rent for both March and April at the end of February because I'm going to be busy packing in the next few weeks.
