MBI Chair Report- October 2016

"Overeaters Anonymous has no opinion on outside issues; hence the OA name ought never be brought into public controversy (OA Tradition Ten).

Greetings!

Reflecting on what I want to share about this tradition, I was drawn to our literature – *The Twelve Steps and Twelve Traditions of Overeater Anonymous* for guidance. The very first paragraph of Tradition Ten discusses how it might seem a good idea that OA which is so supportive of our recovery might use its resources to influence other causes. However, the discussion proceeds to caution us of the dangers that arise to our Fellowship if we choose that path. Members of our Fellowship come from a wide diversity of religious, political, social, etc., traditions; we have numerous points of views. OA meetings are not the place to voice these opinions. "As individuals we are free to believe in and work for any cause we choose" (p. 185). Nevertheless, we are guided to leave all those issues outside when we enter our OA meetings. We must keep in mind that our primary purpose is to reach out to those who are still suffering from this deadly disease. Such conversations can interfere with this goal and confuse members. During this highly charged political campaign in this country, it is important for us to remember we come together to support each other in our recovery and to reach out to those still suffering. We cannot afford to have anything interfere with that.

I am just returning from our Fall Into Recovery Retreat! It was an extraordinary experience. The opportunity to be away and spend time reflecting on the twelve STEPS, the tools and slogans and meditation was empowering and renewing. We also had time to be with each other and share our experience, strength and hope. We unanimously voted to do it again next year! A special thank you to Helen L (Woburn), Paulina S (Lexington), Suzanne D and Jean B (Revere) for all their efforts and hard work to make it happen.

Reminder, the Thanksgiving Thank-a-thon will be on Thursday, November 24th in the Lawrence Memorial Hospital, Medford, MA. A flyer will be available next week. The structure of the day will be 1 hour meetings from 7am ending at 1pm. There will be at least one qualifier for each meeting.

Thank you for your ongoing support of our intergroup. It would not exist without your service and financial funding. It is a structure which allows us to fulfill our responsibility to reach out those who are still suffering from this deadly disease. Our August income had 1528.50 in group donations, 660.00 in retreat reservations (we had 4 in August, 1 in July for a total of \$825 being held for the retreat as of 8/31), there have been more in September see notes below. We also collected \$45 from the MBI 7th tradition collection; people who took t-shirts at the meeting ahead of the convention giveaway were asked to contribute to the 7th tradition. September income is expected to be high with more retreat reservations coming in along with group donations. Thanks to those groups who contributed in August, a list appears below.

August expenses beyond the usual included 876.00 for our annual accountant’s bill, 25.00 donation to the hospital for 7/23 workshop, 150.00 for raffle baskets (2x75) for the OA World Convention (one was gift cards, the other one was a \$75 money tree (the person who won it sent us a nice note thanking us for donating it and said she used the money to buy convention CDs); both baskets earned a lot of money for World Service. We also bought more OA literature for 240.80.

Upcoming in late September or possibly early October we will be paying for the retreat. We can have people sign up through Sept. 30th, they will bill us. All rooms will be singles unless a double is requested.

In September we will also have expenses from the Region 6 Fall Assembly. Upcoming in October will be our quarterly donations to R6 and WSO. We are in good financial condition and whatever happens I trust HP will take care of us.
